This document represents an important update to an earlier traded cluster study that provided available regional cluster information for the years 2001 and 2004. New data is now available for 2006 and this update provides a summary of the cluster analysis using 2006 employment, average wage, and number of establishments by cluster definition. This is a continuing regional collaboration between the University and the Economic Development Organizations in Charlotte, Lee, and Collier Counties.

Industry Clusters are geographic concentrations of business suppliers, producers, service providers, and associated institutions that increase productivity and give a competitive advantage to the firms and the overall business or cluster. This research study focuses on traded industry clusters in the Southwest Florida region.

The project was conducted by Florida Gulf Coast University's Regional Economic Research Institute (RERI) with support from the regional economic development organizations. This is a continuing part of our mission to improve the overall understanding of the regional economy.

EXECUTIVE SUMMARY

This study is the result of collaboration between Florida Gulf Coast University's Regional Economic Research Institute (RERI) and the economic development organizations in Charlotte, Collier, and Lee Counties. A previous cluster analysis, "Traded Business Clusters, Charlotte, Collier, and Lee Counties," was completed in June of 2006 using 2004 labor data. This study updates the previous cluster analysis by:

- Using the 2006 annual labor data from Bureau of Labor Statistics and Florida's Agency for Workforce Innovation;
- Replaces the medical device manufacturing cluster with a broader life sciences cluster; and
- Reports on the number of establishments as well as average annual wage, employment, and location quotients (LQ).

The 2006 cluster analysis was completed for Charlotte, Collier, and Lee Counties for ten specific clusters of interest (regional LQ shown in parentheses):

1. Entertainment Services	(2.69)
2. Visitor Services (Hospitality and Tourism)	(2.33)
3. Building Component Manufacturing	(1.31)
4. Life Sciences	(1.24)
5. Business Services	(1.16)
6. Printing and Publishing	(0.90)
7. Financial Services	(0.86)
8. Transportation and Warehousing	(0.83)
9. Wholesale Distribution Services (Durable Goods)	(0.81)
10. Software and Computer Services	(0.54)

The location quotient is the percent of employment in the regional cluster relative the percent employment in the same cluster for the nation. A high LQ represents a high concentration of employment in that regional cluster.

Michael Porter of the Harvard Business School and the *Institute for Strategy and Competitiveness* has studied industry clusters and competition for a number of years and is a well-known expert in the field of cluster analysis. Porter's website, www.isc.hbs.edu, provides a good definition and overview of industry clusters:

- *“Clusters are geographic concentrations of interconnected companies, specialized suppliers, service providers, and associated institutions in a particular field that are present in a nation or region.”*
- *“Clusters arise because they increase the productivity with which companies compete.”*
- *“The development and upgrading of clusters is an important agenda for governments, companies, and other institutions. Cluster development initiatives are an important new direction in economic policy, building on earlier efforts in macroeconomic stabilization, privatization, market opening, and reducing the costs of doing business.”*

It is hoped that this research will provide a better understanding of the existing industries and clusters and assist economic development organizations and policymakers in their efforts to target certain industries and industry clusters.

The Southwest Florida coastal counties and the region have a large percentage of employment in entertainment and visitor services clusters, as shown in the following tables. The entertainment cluster has a location quotient well over 1.0 for each of the counties and for the region. This indicates a much higher percentage of employment in this regional cluster than the average for the

nation as a whole. The region’s beaches, mild weather, recreational opportunities and other amenities provide the region with a competitive advantage in these clusters. The entertainment cluster location quotient for the region was 2.69, employment was 13,084, average annual wage was \$31,507, and there were 675 establishments in the cluster.

The visitor services cluster also had a high location quotient (LQ) of 2.33 indicating a large percentage of employment in this cluster relative to the percentage of employment for the nation on average. The regional employment in 2006 was 25,379 with an average annual wage of \$29,487. The three coastal counties had 1,123 establishments in the visitors services cluster.

The building component manufacturing sector had the next highest location quotient with 1.31. Employment was 7,496 with an average annual wage of \$39,866 and the research identified 416 regional establishments. This cluster has been supporting the area's building sector which currently is going through a major correction as the national economy has slowed considerably in 2008.

The life sciences cluster includes patient services, manufacturing, and research. Additional detailed information on the sector is included in the main body of the paper. Life sciences are a key cluster for the region with an average location quotient of 1.24 and 2006 employment of more than 26,462. The confidentiality requirements placed on the release of data requires that Lee Memorial Health System workforce numbers be keep confidential and are not included in the total for Lee County. The Lee Memorial Health System website reports that they have over 9,000 employees which would bring the Lee County employment total to about 20,000 and the region to almost 35,000 employees.

The 2006 average annual wage for life sciences is \$53,455 and there were 2,179 establishments identified in this region's cluster.

The regional business services cluster has a 2006 location quotient of 1.16 indicating that employment was 16 percent higher than the national average for this cluster. There were 33,741 employees with an average annual wage of \$36,734 and 5,654 establishments.

The printing and publishing cluster had a location quotient slightly below 1.0 indicating that employment in this cluster was below the national average.

This suggests that printing and publishing services are most likely being imported into the region. The employment in 2006 was 1,789 with an average annual wage of \$44,304 and 291 establishments.

The financial services cluster had a location quotient of 0.86 which is below 1.0 or the national average. The 2006 employment level was 7,906 with an average annual wage of \$58,918 and 1,091 establishments. The study found that the average annual wage varied considerably between the various counties with Collier County having the highest average annual wage of \$76,775.

The transportation and warehousing cluster had a location quotient of 0.83 and employment of 5,837. The 2006 average annual wage was \$52,269 and the study identified 725 establishments.

The wholesale (durable goods) distribution cluster had the next highest location quotient at 0.81. This indicates that the percent of employment in wholesale distribution was below the national average and that the region was likely importing some of the wholesale distribution services. Employment was 5,448 with an average annual wage of \$53,442 and 725 establishments.

An important cluster that is being recruited by the region is the software and computer services. The location quotient for the region is 0.54 which is relatively low indicating that many of these services are being imported into the region. There were 1,590 employees with a relatively high average annual wage of \$67,015 and 407 establishments.

This study is an update of a previous study completed in June of 2006. It provides key data to provide a better understanding of employment and annual wages in the region and by county. The data show that the region has strong clusters in entertainment services, and visitor services. The life sciences cluster is strong in patient services but there is a desire to expand the life sciences into additional manufacturing and research. The business services cluster continues to be a key employer in the region. Opportunities exist to diversify the economy and to expand high wage employment in areas such as life sciences and software and computer services. Detailed tables and descriptions of the study are provided in the main body as well as the appendix of this report.

Methodology

The study is based on 2006 labor data obtained from the U.S. Bureau of Labor Statistics and Florida’s Agency for Workforce Innovation. The summary statistics are based on available information that may be limited due to non-disclosure requirements. The cluster definitions are based on the work done in the original study and are not repeated in this update study. The life sciences cluster definition includes manufacturing, research and development, and patient services. The North American Industry Classification Codes (NAICS) that define each cluster are contained in the detailed summary tables.

The location quotient (LQ) is defined as:

$$\frac{(\textit{Local employment in the cluster} / \textit{Total local employment})}{(\textit{National employment in the cluster} / \textit{Total National employment})}$$

If a cluster has a higher percentage of employment in the local economy than the nation, the LQ is greater than one; it is likely to be exporting the product or service outside the local economy. If the LQ is less than one, it is likely that the local economy will be importing some of the good or service.

Study Findings

The 2006 cluster information is first presented at a summary level that compares the labor data for all ten clusters by location quotient and average annual wage. Next, the detailed information is presented for three key clusters of interest including:

- Life Sciences;
- Computer and Software Design; and
- Wholesale Distribution

In order to keep the study report manageable, the detailed analysis charts for the other clusters are provided in Appendix A which includes 21 detailed cluster tables for the remaining seven clusters and the three counties. The definitions of the clusters are contained in the detail cluster tables and are defined using the North American Industry Classification System or NAICS. The summary level cluster information is presented in six tables sorted by location quotient and average annual wage and by each county.

The Charlotte County information is presented in the following two tables.

Charlotte County has a location quotient above one for the following clusters:

- Entertainment with a LQ of 1.86;
- Life Sciences with a LQ of 1.71; and
- Visitor Services with a LQ of 1.44.

The high values for Entertainment and Visitor services indicate that Charlotte County has a higher percentage of its employment in recreational activities such as golf courses, water-front activities, other amusement and recreational activities, accommodations, and food services. Given the climate, recreational activities, and beaches, it is not surprising that Charlotte County and the region have a competitive advantage in visitor services. Life Sciences had the second highest cluster location quotient of 1.73 with a majority of the life sciences cluster employment in patient services and some employment in medical equipment and supplies manufacturing. The strong location indicator for life sciences reflects the higher regional demand for health care services primarily due to the high percentage of retirees and seasonal visitors to the region.

The remaining Charlotte County clusters did not have sufficient employment relative to the nation to have a location quotient above one. These included:

- Business Services (LQ of 0.88);
- Transportation and Warehousing (LQ of 0.56);
- Wholesale (Durable Goods) Distribution Services (LQ of 0.56);
- Software and Computer Services (LQ of 0.15);
- Printing and Publishing (LQ of 0.11);
- Financial Services with a LQ that could not be disclosed due to confidentiality requirements but the labor data identified 115 establishments; and
- Building Component Manufacturing with a LQ that could not be disclosed due to confidentiality requirements but the labor data identified 44 establishments.

Charlotte County's clusters were also sorted by average annual wage. Life Sciences had the highest average annual wage in 2006 with \$44,343, followed by Financial Services at \$43,501 and Wholesale Services at \$41,007. The Building Component Manufacturing, Transportation and Warehousing, Software and Computer Services, and Business Services clusters had average annual wages between \$33,815 and \$40,941. The lowest average annual wages were for the Visitor Services and Entertainment clusters at \$19,260 and \$18,652, respectively.

The 2006 Collier County cluster data are presented in the next two tables. There are three clusters that had a location quotient above one:

- Entertainment (LQ of 3.77);
- Visitor Services (LQ of 3.17); and
- Business Services (LQ of 1.34).

Entertainment and Visitor Services had very high location quotients indicating the proportionally high levels of employment in these clusters relative to the nation. This reflects Collier County's relative competitive advantage in providing these services. Business Services was the only other cluster analyzed that had a location quotient above one at 1.34 implying that, relative to the nation, employment was relatively high.

Life Sciences, Building Component Manufacturing, and Financial Services had location quotients between 0.93 and 0.98 which implies that local employment is close to the national percentage of employment in those clusters. Wholesale Services, Printing and Publishing, Software and Computer Services, and Transportation and Warehousing Clusters had location quotients between 0.59 and 0.62 indicating that Collier County was most likely importing some of these services.

Collier County's clusters are also sorted by average annual wage. The highest 2006 average wage was for the Software and Computer Services cluster at \$86,130. This was followed by Financial Services at \$76,775 and Wholesale Distribution Services at \$62,364. Transportation and Warehousing and Life Sciences had relatively high average annual wages of \$61,196 and \$55,936, respectively. Printing and Publishing, Business Services, and Building Component Manufacturing had average annual wages between \$38,880 and \$49,471. The lowest average annual wages were for employees in the Entertainment and Visitor Services Clusters with \$35,796 and \$32,136, respectively.

Lee County had six clusters with a location quotient above one:

- Entertainment (LQ of 1.87);
- Visitor Services (LQ of 1.60);
- Building Component Manufacturing (LQ 1.46);
- Life Sciences (LQ of 1.29);
- Printing and Publishing (LQ of 1.21); and
- Business Services (LQ of 1.09).

Each of these clusters has employment proportionally above the national level and is likely to be exporting some of these products and services outside Lee County.

The two highest average annual wage clusters for Lee County are Software and Computer Services at \$55,838 and Life Sciences at \$55,710. Wholesale Distribution, Financial Services, and Transportation and Warehousing had average annual wages between \$50,198 and \$51,165. Building Component Manufacturing, Printing and Publishing, and Business Services had average annual wages between \$35,754 and \$40,170. The lowest average annual wage was reported for Entertainment and Visitor Services with \$29,671 and \$28,072, respectively.

- Wholesale Distribution Services.

The software and computer services detailed cluster data are shown in Tables 3.17 through 3.19. Charlotte County has 39 establishments with more than 75 employees primarily employed in customer computer programming and computer systems design services with an average annual wage of approximately \$39,000. The cluster has a very small location quotient of 0.15 indicating that a large percentage of software and computer services are imported from outside the county. The 2006 average annual wage for Charlotte County was \$38,735.

Collier County has over 600 employees in the Software and Computer Services Cluster and 149 establishments, as shown in Table 3.18. Most employees are in custom computer programming services, computer systems design services, and internet service providers. The cluster's 2006 location quotient was 0.59 which indicates that Collier County's employment is lower in percentage than that for the nation. The location quotient for customer computer programming services and computer system design services was 0.18 and 0.17 which are considered very low location quotients. Collier County had a location quotient of 0.98 for internet service providers which indicates that the county had

about the same percentage of employees in the county as the average for the nation. This cluster is often considered a good candidate for diversifying the regional economy due to the high average annual wage, which was \$86,130 for Collier County.

The software and computer services cluster for Lee County had 886 employees, 219 establishments, and an average annual wage of \$55,838 as shown in Table 3.19. The overall cluster location quotient was 0.53 which is driven by an average location quotient of 0.99 for internet service providers. The largest employment areas in the cluster were in custom computer programming

services with 283 employees, computer systems design services with 153, internet service providers with 171 employees, and other computer related services with 93 employees. The county's employment levels in custom computer programming services and custom systems design services are well below the national average (proportional) employment for these sectors.

Life Sciences are an area of interest for economic development, especially those fields engaged in research and development. Table 3.20 provides a

summary of the life sciences cluster for Charlotte County which has 5,450 employees, 387 establishments, and an average annual wage of \$44,343. The location quotient is very high with a value of 1.71 which implies that employment in the county is 71 percent higher than the proportional cluster employment on average for the nation. Most of the employment is service-based. The labor data indicate that county has very low employment in life science manufacturing, research, and development.

Collier County has a strong life science service cluster that includes 10,097 employees, 729 establishments, and an average annual wage of \$55,936 as shown in Table 3.21. There are 22 establishments and 276 employees identified working in the medical equipment and supplies manufacturing industry. There were no firms identified in the NAICS industry categories for life science research and development.

Lee County also had a strong life sciences service cluster with over 10,915 employees, 1,063 establishments, and an average annual wage of \$56,699, as shown in Table 3.22. The Lee County life science employment numbers shown in the table do not include Lee Memorial Health System's employment due to confidentiality rules. However, the Lee Memorial Health System's website reports that they have over 9,000 employees. This would increase Lee County's life science cluster employment to approximately 20,000. Life science and computer services are both expected to be very fast growth industries creating opportunities for economic development and higher wage employment in the region.

Charlotte County's Wholesale Distribution (Durable Goods) Cluster had 341 employees, 78 establishments, and an average annual wage of \$41,007 as shown in Table 3.23. The 2006 location quotient was 0.56 rising from 0.43 in 2001. This shows that the Charlotte County's wholesale distribution cluster employment has grown faster than national employment but that employment in this cluster is a lower percentage of total Charlotte County employment than that of the nation. The majority of employment was in lumber and construction supply merchant wholesalers, electric goods merchant wholesalers, hardware and plumbing merchant wholesalers, and machinery and supply merchant wholesalers.

Collier County's Wholesale Distribution (Durable Goods) cluster has 1,417 employees, 229 establishments, and a relatively high average annual wage of \$62,364 and is shown in Table 3.24. The 2006 location quotient is 0.62 indicating that Collier County employment in the wholesale sector is only 62 percent of the national percentage of employment in this cluster. The major Collier County employers in this cluster are lumber and construction merchant wholesalers, commercial equipment wholesalers, electric goods merchant wholesalers, machinery and supply merchant wholesalers, and miscellaneous durable goods merchant wholesalers. The only one of these with a location quotient above one was the lumber and construction supply merchant wholesalers with a location quotient of 1.28. The fast pace of residential and commercial construction through 2005 created a strong demand for wholesale merchants to supply the local construction industry.

Lee County's Wholesale Distribution (Durable Goods) cluster employed 3,690, included 418 establishments, and had an average annual wage of \$51,165 as shown in Table 3.25. 2.0 Concluding Thoughts

This study has updated numerous tables with information from the U.S. Bureau of Labor Statistics and Florida's Agency for Workforce Innovation to provide the best available data on ten various clusters by county. The level of detail has resulted in 36 detailed tables that are presented in this paper. It is clear from the research that the entertainment, visitor services, and life sciences patient service are large employers in our regional economy. The work done on software and computer design services, life sciences research and development activities, and wholesale distribution services reveal that these sectors are fairly small employers relative to the average percentage of employment at the national level. Software and computer design services and life sciences are expected to be two of the fastest growing clusters, creating opportunities for the region to expand its workforce in these clusters, and to diversify the overall regional economy with higher annual wage jobs, creating wealth for the region.
